


"Encountered and assisted two tenants having difficulty moving their two-piece couch at their residence at 400 W. Rich St.









Final Thoughts from the Executive Director

We are confident this report has illustrated that we work everyday to improve Franklinton in any way possible. It can be easy to discount the importance of a clean environment when other more immediate and higher priority challenges exist, but we are proving it is equally important when you consider holistic and all-encompassing solutions to issues. Do we still have serious challenges? Absolutely. Are we better equipped now more than ever to face them? Absolutely. We've never had the opportunity to employ folks 5 days a week, 8 hours a day, to address these issues, but the SID has allowed this opportunity. We are only 5.5 months in and seeing incredible results.

Combined with FBOT's continued mission to Advocate, Beautify, Connect, we feel confident we are on the right path.

The future of the neighborhood is incredible with new businesses arriving and market rate and affordable housing going up simultaneously. Gravity II, Thrive's work on the Mount Carmel site, CoverMyMeds, units being built by Franklinton Development Association, Finance Fund, and Homeport, all are underway right now. We still have work to do to help protect our legacy residents and businesses from skyrocketing rents, but our messaging on this has stayed consistent and strong, and the developers do notice.

FBOT is proud to be part of all the activity that makes this neighborhood strong. And we close with the words from the Secretary of the then West Side Board of Trade, established on March 2, 1904, contained within the program for the 1911 celebration of the elevation of the railroad tracks on Broad St., at Station 67: "Our mission will not be fulfilled until we can place our section on the same plane as any other part of Columbus as a desirable place for the home-seeker (and business) to live."
